Dear Chair DeLauro and Ranking Member Granger:

I am requesting funding for the Manet Community Health Center Satellite Clinic in Attleboro.

The entity to receive funding for this project is the Manet Community Health Center, located at North Main St., Attleboro, MA 02703.

The funding would be used to fulfill Manet's plan to open a satellite health center in the heart of Attleboro's downtown, at 8 North Main Street, for primary care, mental health, and substance counseling services. Manet comes to Attleboro after a significant and contemplative process that began in January of 2019. Manet's physician, nurse and social work team will serve 1,300 new patients in the first year. Additionally, 325 existing patients at Manet Taunton will have the option to transfer their care to the new Attleboro location. Services provided at the site will include primary medical care for all ages, nutrition therapy, chronic disease care management, access to specialists, preventive health screenings, behavioral health counseling, addiction services and COVID-19 services including COVID care, testing and screening and vaccination services. Manet will also provide services and further supplement access through telehealth services; and serve homeless residents.
