Dear Chair DeLauro and Ranking Member Granger:

I am requesting funding for "Fall River Waterfront Stormwater Corridor" in fiscal year 2023.

The entity to receive funding for this project is City of Fall River, located at One Government Center, Fall River, MA 02722.

The funding would be used to update a Stormwater Conveyance System. This system includes large box culverts and specially designed and configured Manholes that will allow a large amount of stormwater to pass through this newly constructed transportation corridor. The City's wastewater collection and treatment system is primarily a combined system with more than 200 miles of sewers that transport both sanitary and stormwater flows to the Fall River wastewater treatment facility (WWTF) or one of the 17 CSO's that discharges to the Taunton River or Mount Hope Bay. Sewer age and development over time have resulted in capacity and condition issues that must be addressed as part of infrastructure renewal projects.
